Mayor Sowden called the meeting to order and requested the Borough Clerk to call the roll. Upon roll call, the following members of the Governing Body were present: Mrs. Carnes, Mr. Formica, Mrs. Heath, Mr. Skellenger, Mr. Snyder and Mayor Sowden.

Absent: Mr. Limon

Mayor Sowden led the assembly in the flag salute.

Mayor Sowden stated "This meeting is being held in compliance with the provisions of the Open Public Meetings Act, N.J.S.A. 10:4-6 et sequentes. It has been properly advertised by posting in Borough Hall and posted on the Borough website, which adequate notice has been certified by the Clerk."

PRESENTATIONS

Mayor Sowden recognized Keri Marino and Officer Lospinuso and Officer Rotunda for receiving an award from Congressman Gottheimer.

Mrs. Heath commented that we are all very proud of you and you make the town very proud.

COMMITTEE REPORTS

Mrs. Heath commented that Recreation is moving along with the 9/11 memorial and we are getting a good response on the pavers. The trench is going to be done so that the lighting can be put on the mineral.

Mayor Sowden asked how the walk for addiction go.

Mrs. Heath commented that the police were there from all the departments. It was better than ever. The wall keeps on getting bigger and bigger with the pictures.

Mr. Skellenger had nothing to report.

Mr. Formica commented that the Sussex County Commissioners approved our grant for the walking path. We will be getting our first installation of \$25,000 this year.

Mayor Sowden commented to just remember that there is another grant we received from the state, a year ago, that we need to get into very shortly or they will pull it. This grant was for a playground grant, it was for the fields and things like that.

Mr. Spidaletto commented that we used that grant money already.

Mr. Skellenger thanked the Mayor and Neil for getting the paperwork over to the county for the grant.

Mrs. Carnes commented that the EDC Committee will be meeting in September. There is a new business opening, Metropolitan Dermatology, soon; in the old Dr. Hrabachuck building. In addition to congratulating our hometown heroes, congratulations to Miss Franklin for placing as 1st runner up for the Queen of the Fair.

Mr. Snyder commented that the ordinance committee met and discussed water meters. We are looking into changing insurance coverage due to the cost of participating in SHBP.

Mr. Spidaletto commented that he has been corresponding with both unions and they are aware of some of the options out there and the cost of the state health benefits is one of the reasons for the increase in the budget. We are exploring other options as this coming year's increase could be about 23 percent.

Mayor Sowden commented that there is a rail to trails meeting next week.

OPEN PUBLIC SESSION

Mr. Skellenger made a motion to open the meeting to the public for anyone wishing to address the Governing Body. Seconded by Mr. Formica. All were in favor.

Ms. Joanne Tatka stepped forward. Ms. Tatka voiced concerns regarding the increase in the tax bills.

Mr. Ursin commented that the timing of the revaluation is not the Borough's choice. The County Tax Board makes the decision about when a town has to do a revaluation and so the fact that the revaluation was done this year and there was a tax increase.

Ms. Tatka commented that they have been revaluating for 5 years.

Mr. Ursin commented that the revaluation that was done, your tax assessor did the revaluation over a five-year period to soften the blow rather than all at once. He would have to explain the how the mechanics of that work.

Ms. Tatka commented that it was not raised very evenly. Ms. Tatka commented that this does not make sense. If this is the case, then you have to start cutting back. Ms. Tatka questioned what the 40x60 building would be used for.

Mayor Sowden commented that this is the new salt shed.

Ms. Tatka asked if the brush could be cut at the intersection of Maple Road and Wildcat and she has not seen that anything has been with that as of yet.

Mr. Formica commented that this was brought up at the last meeting and asked if anything was noticed.

Mr. Spidaletto commented he believes it was noticed but will confirm.

Ms. Tatka asked who was charged the 2 million gallons of water on Route 23 Franklin Square.

Mr. Spidaletto commented that it was the Quarry Grill. There was a faulty meter that ran for a while and it has since been corrected.

Ms. Tatka commented that she sees the police negotiations were made and she does not see, you used to report whenever someone went up a step and you do not do that anymore so we are not aware of salaries that are being made, is there a reason for that why they are not going before a meeting.

Mayor Sowden commented that he does not recall that. We will look into this.

Ms. Tatka questioned the emergency resolution.

Mr. Spidaletto commented that the number listed there is what the emergency appropriation is for. Ms. Tatka questioned the resolution for the test well drilling and asked if it was for Ryan Homes.

Mayor Sowden commented that this is for Frankin Borough and it is being done behind Shoprite Liquors.

Ms. Tatka commented that you are going to drill a well there and she believes that for a couple years the Hardyston School had their own well and they went on Franklin Water, why did they go onto Franklin Water.

Mayor Sowden commented that PFAS's were very high in their well.

Ms. Tatka asked what is the real reason for the big budget increase.

Mayor Sowden commented schools.

Mr. Spidaletto commented that if you look at the numbers in regards to where we are at, we had a 2.975% increase. Wallkill Valley had a 4.08 increase and Franklin local schools had a 3.78 increase. This council has consistently been frugal and on top of things as far as their budget. They are in good shape financially as well as keeping their surplus in place. Everything went up in cost, exponentially.

Ms. Tatka commented that we have all those expenses too and we only have so much money to cover those expenses.

Mr. Formica commented that we raised 2.9% on a 9-million-dollar budget; the high school raised 4% on a 20-million-dollar budget and the elementary school raised almost 4% and they at a 15-million-dollar budget. Next week there is a board of education meeting on the 18th at 7pm and they are doing a mid-contract negotiation with their superintendent who is looking for a raise. We definitely tried with what we can to keep everything the same. Mr. Formica commented that his portion of the taxes that went up on the town was only a couple hundred but it went up \$900 for the schools and the county. We are trying everything we can here but it seems while we are trying to keep it in line the schools are just doing what they want to do.

Mayor Sowden commented that no, sometimes they are and sometimes they are being made to do.

Mr. Formica commented that he is seeing a lot of waste and he is more than willing to say that on the record.

Mrs. Christine Affinito stepped forward. Mrs. Affinito raised concerns regarding the policy and procedures that the Recreation Committee needs to follow.

Mr. Formica commented that the mulch for the playground, somehow on the operating budget it got left out, so from what he was told; Michelle took it from the field use fees because that is not generally part of the operating budget so it was kind of a safe spot to us for now as far as it being reimbursed, I'm not sure of.

Mrs. Affinito commented that she is not questioning that when she went back and asked, should we have a vote for this; she was told no, I have the power. So, here's the money that is being used from one of the Recreation accounts that we are willing to vote on but we don't have to because somebody has the power. Similar to that \$25,000 which there is no vote for and no motion sheet.

Mr. Formica commented that there was a vote for that by the Council.

Mrs. Carnes commented that is at the Council level and I think, Neil you provided that documentation.

Mr. Spidaletto commented that he has showed the documentation to members of the committee on multiple occasions.

Mrs. Affinito commented that when a meeting was held when she first came on, we sat at that table and Michelle.

Mr. Spidaletto commented that he brought out the paperwork during that meeting and showed it, it was March 11, 2025 and it states the conversation that occurred.

Mrs. Affinito commented that when we had that conversation here in the lunch room and that point was brought up the first instinct was that was a mistake and she pointed out all of the transactions that was the only transaction that says as per this person and this person that transfer was made.

Mr. Formica commented that when the playground was done there was a Millie Harden Fund. When the playground was getting ready to go, in order to order the playground, they had to encumber the money so they took the money out of a CD and put it into an account. So then when the money was getting transferred back into the account, they left \$25,000 in the carnival account because there was no playground account at that time. That way if there was added expenses toward the end of playground the money was still allocated, that was when Debbie Bonnanno was here. When she left, Andrew came and the money never got transferred. He was here for about a year and then he left and Michelle came and that is when the money finally got transferred back. And that went back to the Millie Harden Fund. In regards to the dugouts, there was a contractor that we were going to use but it did not work out. Talking with the QPA about different options to go through, I was going to do with the DPW and got involved with a couple other projects.

Mrs. Heath asked why \$4,800 was used to spread the mulch, when DPW just needed to straighten it out. Mrs. Heath is appalled that we hired an outside contractor for \$4,800 to spread mulch, that volunteers could have done.

Mrs. Carnes asked what is the delay with the bricks.

Mrs. Affinito commented that we have figured out how to get through the brick situation. There is a string of emails; we found a brick company which we were having problems with because they are in Florida. We found that brick company because in the concession stand, we found a brick that had Franklin Borough's name on it from Bricks R Us and figured it was a company that we already used. We tried to move forward with it and we ran into obstacles because they are in Florida and don't know if they can sell in New Jersey. We had the orders coming in which somebody had held for three weeks and did nothing with. We reached out to the outside landscaper that we hired to do this for us and he is going to get the bricks for us. We have received donations for 9/11; in October we sent letters out to everybody which is why the \$1,000 fishing derby check didn't make sense to us because Ascend told us they were going to donate \$1,000.

Mr. Formica commented that he is the one who solicited the \$1,000 for the police and fire department.

Mrs. Affinito commented that she hopes the check says fishing derby. As long as it does then I feel like somebody did something right.

Mr. Matthew Daspin stepped forward. Mr. Daspin voiced concerns regarding the zoning officer's hours and the over growth of grass and trees throughout the town.

Mr. Peter Liverakos stepped forward. Mr. Liverakos voiced his concerns regarding the budget and the tax bills. What programs are being instituted to restrain cost for the current fiscal year.

Mr. Formica commented that we are looking into shared services with other towns.

Mr. Ursin commented that this council only controls the municipal part of the budget. That is 30% or less; if you look at the municipal budget, it is small number of employees compared with the budgets in the other governments.

There being no one else present who wished to address the Governing Body, Mr. Skellenger made a motion to close the meeting to the public, seconded by Mr. Formica. All were in favor.

Mrs. Heath commented that Mrs. Tatka brought up a good point, in the past when we had a reevaluation our tax rate was adjusted but she sees this time it was not.

Mrs. Tatka commented that Rachel made a motion to pay the senior center assistant at a rate of \$15.50 but the resolution says \$15.92. Which is it?

Mr. Spidaletto commented that the resolution is correct, that is minimum wage.

Mr. Ursin commented that because the resolution is correct then its ok.

Mrs. Tatka commented that if you wanted to cut the budget, you had your chance tonight by keeping the police chief at what he was making not giving him another raise. Nobody is going to merge with Franklin's Police Department because we are overstaffed. You are not going to cut anything by your actions tonight.

Mr. Snyder commented that we were told, when going over the budget this year, that the surplus amount we had which we used \$750,000 of but we were told that we should not go under that amount, that's hardly anything these days.

Mrs. Carnes commented that it was explained that you need to have a certain amount to pay bills for "x" amount of time.

Mr. Snyder commented that the committee wanted to do a little bit more but we thought it better that we didn't. My understanding from what the CFO said it would be \$118 increase on the average assessed home.

### **RESOLUTION REQUESTING A FULL, INDEPENDENT, AND TRANSPARENT INVESTIGATION INTO THE IMPROPER REGISTRATION OF NON-CITIZENS TO VOTE IN NEW JERSEY AND CALLING FOR ADDITIONAL SAFEGUARDS TO PROTECT ELECTION INTEGRITY**

**WHEREAS**, the integrity of our elections is fundamental to the democratic process and to maintaining public confidence in our government; and

**WHEREAS**, on July 21, 2026, the Governor of New Jersey, Mikie Sherrill, announced that approximately six thousand six hundred (6,600) individuals who had indicated that they were not United States citizens were improperly registered to vote as a result of a software error; and

**WHEREAS**, Governor Sherrill further stated that a review found fewer than four hundred (400) of the individuals newly registered as a result of the error subsequently cast ballots; and

**WHEREAS**, regardless of whether any individual election was ultimately determined to have been affected, the improper registration of individuals who are not eligible to vote raises serious concerns regarding the accuracy, security, oversight, and integrity of New Jersey's voter registration system; and

**WHEREAS**, the public deserves a complete accounting of how this error occurred, how long it remained undetected, what safeguards failed, and what steps will be taken to ensure that a similar failure cannot occur again; and

**WHEREAS**, the people of New Jersey deserve to know which counties and jurisdictions the affected individuals were registered, in which elections those ballots were cast, and whether any races or election outcomes may have been affected by those ballots; and

**WHEREAS**, the investigation should be conducted in a transparent and independent manner, including the creation of a bi-cameral, bi-partisan legislative investigative committee with subpoena power and the ability to question testifiers under oath;

**WHEREAS**, the integrity of voter registration should not rely solely upon one agency, database, software system, or automated process, and additional independent safeguards and verification procedures should be considered to ensure that only eligible individuals are registered to vote; and

4. The elections in which any affected individuals cast ballots;
5. The number of ballots cast by affected individuals in each election and Jurisdiction;
6. Whether any affected ballots were cast in elections decided by a margin equal to or less than the number of potentially ineligible ballots case;
7. If any federal, state, county or local election results may have been affected or require further review;
8. What corrective actions and safeguards will be implemented to prevent similar errors in the future.

**BE IT FURTHER RESOLVED** that the Franklin Borough Governing Body call for an immediate suspension of automatic voter registration at every MVC agency and their website;
