Notice is hereby given that on **July 22, 2026 @ 10:30 AM (Prevailing time)**, **electronically sealed bids will be opened and conducted in the electronic platform per N.J.A.C. 5:34-1 et seq. #### **Submission of Bid:**

If indicated, bid proposals must be accompanied by a certified check, cashier's check, or bid bond in the amount of ten percent (10%) of the total amount of the bid, but not over twenty thousand (\$20,000) dollars, and made payable to the Borough of Franklin.

The bidder shall submit a copy of the bid guarantee with electronic submittal and mail PRIOR to bid opening the original to the Municipal Clerk's office, 46 Main Street, Franklin, NJ 07416, prior to bid opening. The bid bond may also be provided in the form of a certified check or cashier's check, as per the provisions outlined in the general requirements of this bid.
