**RESOLUTION AUTHORIZING DONATION OF
MUNICIPAL PROPERTY NO LONGER NEEDED FOR
PUBLIC USE TO THE FRANKLIN VOLUNTEER FIRE
DEPARTMENT**

WHEREAS, the Borough of Franklin is the owner of a 1994 KME Pumper vehicle bearing VIN 1K9AF4284RN058908; and

WHEREAS, said vehicle is no longer needed for public use; and

WHEREAS, the Franklin Volunteer Fire Department has expressed a desire to acquire said vehicle so that it may be sold and the sales proceeds used for the purchase of Fire Department equipment; and

WHEREAS, the Borough Council has determined that it is in the best interest of the Borough to donate the vehicle to the Franklin Volunteer Fire Department for its intended purpose.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Franklin as follows:


1. The 1994 KME Pumper vehicle bearing VIN 1K9AF4284RN058908 is hereby declared to be surplus personal property of the Borough; and
2. Said vehicle shall be donated to the Franklin Volunteer Fire Department; and
3. The Borough makes no representations regarding the condition or suitability of the vehicle, and said vehicle is being donated "as is" without warranties, either express or implied and on the condition that that the recipient shall hold the Borough harmless for any claims arising out of the vehicle after transfer of title to the Franklin Volunteer Fire Department; and
4. The Mayor and Township Clerk are hereby authorized to execute any and all documents necessary to effectively transfer title of the vehicle to the Franklin Volunteer Fire Department.
