**A RESOLUTION OF THE BOROUGH OF FRANKLIN  
AUTHORIZING A CONTRACT WITH ADVANCED PLUMBING  
AND DRAIN CLEANING, INC. FOR SANITARY SEWER VIDEO  
INSPECTION AND JET CLEANING SERVICES**

**WHEREAS**, the Department of Public Works Sewer Division provides for maintenance and repairs to the municipal wastewater distribution system which includes various pipe lines, manholes leading to the SCMUA pump station; and


**WHEREAS**, in anticipation of necessary road paving projects to be completed in the Borough it is recommended that the existing sewer lines within the areas of planned paving be inspected for existing clogs, breaks, root intrusions or other infrastructure vulnerabilities to allow for repairs prior to road paving.

**WHEREAS**, proposals were requested from experienced contractors and Advanced Plumbing and Drain Cleaning, Inc. provided the proposal with the lowest cost to assist the Department of Public Works with the video inspection and jet cleaning of approximately 16,000 feet of 8 and 10 inch sanitary sewer lines.

**WHEREAS**, funds in the amount of \$20,000.00 are available for this purpose within the FY2021 Water and Sewer Operating Budget – I & I Study & Repair budget under account 09-201-55-519-000 for these services.

**NOW THEREFORE, BE IT RESOLVED**, on this 10th day of June 2021, that the Borough Council of the Borough of Franklin does hereby authorize the Mayor to execute a contract, pending the receipt of all necessary documentation, to provide sewer camera inspection and cleaning in an amount not to exceed \$20,000.
