RESOLUTION OF THE GOVERNING BODY OF THE BOROUGH OF FRANKLIN CONCERNING SEWER ALLOCATION FOR 16 PARK DRIVE AND PAST DUE AMOUNTS

WHEREAS, the Borough of Franklin municipal sewer system services 16 Park Drive in Hardyston, New Jersey;

WHEREAS, the property owner applied for a sewer allocation at the time of construction;

WHEREAS, the property received a final certificate of occupancy on August 11, 2014;

WHEREAS, due to an oversight, the property has never been billed for sewer service;

WHEREAS, the Borough has met with the property owner and the property's usage has been reviewed by the Borough of Franklin municipal sewer engineer;

WHEREAS, based upon the usage of the building, the property owner has requested a determination that 8 EDUs is the appropriate allocation;

WHEREAS, the Borough's Sewer engineer has approved this request;

WHEREAS, the Borough's Water and Sewer Collector has calculated the overdue amount to be paid from the date of the certificate of occupancy is \$50,322.72;


WHEREAS, the Borough has negotiated an agreement to waive the interest in exchange for receiving payment within seven days of the date of this resolution;

NOW THEREFORE IT BE RESOLVED by the Borough of Franklin's Mayor and Council as follows:

1. the sewer allocation for 16 Park Drive, Hardyston, New Jersey, Block 62, Lot 18.12 shall be reduced from 12 EDUs to 8 EDUs retroactive to the date of the certificate of occupancy, which is August 11, 2014 provided the payment is made within seven days of the date of this resolution.

2. the Borough will accept the amount of \$50,322.72 as payment in full of all sewer charges through December 31, 2023. This resolution waves the interest due on the payment. In the event that the payment is not made within seven days, the Borough's offer to waive the interest will be withdrawn.
