**RESOLUTION OF THE BOROUGH OF FRANKLIN, COUNTY OF SUSSEX,
STATE OF NEW JERSEY AUTHORIZING THE EXECUTION OF THE
NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION TREATMENT
WORKS APPROVAL PERMIT APPLICATION (TWA-1); STATEMENT OF CONSENT FOR
BLOCK 2401 LOT 21 AS REQUESTED BY AWH CULTIVATION FACILITY**

WHEREAS, an increased allocation with respect to the sanitary sewer system will be required as stated by the Borough Engineer for Block 2401, Lot 21, as set forth in his July 3, 2023 Memorandum. The project will have no impact on the Franklin Borough Sanitary Collection System, and it is necessary for AWH Cultivation Facility to seek consent on behalf of the Borough of Franklin for an approval from the New Jersey Department of Environmental Protection (NJDEP) for a Treatment Works Approval (TWA-1) Permit; and

WHEREAS, it is necessary for the Borough of Franklin to consent to the TWA-1 Permit application to be filed by the applicant with the NJDEP; and

WHEREAS, the TWA-1 application has been reviewed and approved by Mike Vreeland, the Borough Sewer Engineer; and

WHEREAS, the Governing Body for the Borough of Franklin hereby authorizes the Mayor and Borough Clerk to execute the Statement of Consent as part of the TWA-1 Permit application for Block 2401, Lot 21 as requested by AWH Cultivation Facility.

NOW THEREFORE IT BE RESOLVED by the Mayor and Council of the Borough of Franklin, that the Mayor and Borough Clerk are hereby authorized to execute the Statement of Consent form which is part of the NJDEP TWA-1 Permit application concerning the project for Block 2401, Lot 21.
