WHEREAS the Department of Public Works needs, on a timely basis, to purchase goods and procure services utilizing the ESCNJ 22/23-47 Contract, duly authorized under law, to extend contract pricing to local units, per N.J.A.C. 5:34-7 et. Seq.; and

WHEREAS the Borough intends to enter into a contract for the procurement for basketball court improvements to ATT Sports Inc. an authorized vendor under the ESCNJ 22/23-47 Contract, and


WHEREAS, the Chief Financial Officer has certified that funds in the amount not to exceed \$70,400.00 are available in the Municipal Budget and
