RESOLUTION OF THE BOROUGH OF FRANKLIN, COUNTY OF SUSSEX, STATE OF NEW JERSEY, AUTHORIZING THE AWARD OF A REQUIRED DISCLOSURE CONTRACT WITH B&N TREE CARE THE DEPARTMENT OF PUBLIC WORKS

WHEREAS, the Borough of Franklin Department of Public Works has a need for tree cutting and trimming services, and B&N Tree Care of 39 Quarry Road, Wantage, NJ, has a required disclosure contract under the provisions of N.J.S.A. 19:44A-20.4et. Seq., and,

WHEREAS, the Qualified Purchasing Agent has certified that the value of the contract is over the Pay to Play threshold of \$17,500.00 and

WHEREAS, B&N Tree Care of 39 Quarry Road, Wantage, has supplied a quote for:

- Tree care services in an amount not to exceed \$35,000.00

WHEREAS B&N Tree Care is deemed the most advantageous to the Borough based upon Price and other Factors per N.J.S.A.40A:11-6.1 et. Seq., and

WHEREAS, B&N Tree Care has completed and submitted a Business Entity Disclosure Certification and a Personal Contribution Disclosure form, which certifies that the entity has not made any reportable contributions to a candidate in the Borough of Franklin in the previous year and that the contract will prohibit the entity from making any reportable contributions through the term of the agreement, and

WHEREAS, the Purchasing Agent has recommended the contract be awarded in the amount of not to exceed \$35,000.00 and,

WHEREAS the Chief Financial Officer certifies the availability of funds and that the funds shall not exceed \$35,000.00

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of Franklin, County of Sussex, State of New Jersey, as follows:

1. That the contract be and hereby is awarded for tree cutting and trimming services to B&N Tree Care of 39 Quarry Road, Wantage, NJ
2. That the cost for the services aforesaid shall not exceed \$35,000.00
