RESOLUTION OF THE BOROUGH OF FRANKLIN, COUNTY OF SUSSEX, STATE OF NEW JERSEY, AUTHORIZING THE AWARD OF A REQUIRED DISCLOSURE CONTRACT WITH B.G. COSTON AND SONS LLC FOR THE DEPARTMENT OF PUBLIC WORKS

WHEREAS the Borough of Franklin Department of Public Works needs crushing and milling services of concrete and blacktop and B.G. Coston and Sons, LLC 3190 Route 94, Franklin NJ, has a required disclosure contract under the provisions of N.J.S.A. 19:44A-20.4et. Seq., and,

WHEREAS, the Qualified Purchasing Agent has certified that the value of the contract is more than the Pay to Play threshold of \$17,500.00 and

WHEREAS, B.G. Coston and Sons, LLC 3190 Route 94, Franklin NJ, has supplied a quote for:

- Crushing and milling of blacktop and concrete at the DPW Facility

WHEREAS, quotes were received from DAG Mobile Aggregate Recycling and

WHEREAS, B.G. Coston and Sons, LLC is deemed the most advantageous to the Borough based upon Price and other Factors per N.J.S.A.40A:11-6.1 et. Seq., and

WHEREAS, B.G. Coston and Sons, LLC has completed and submitted a Business Entity Disclosure Certification and a Personal Contribution Disclosure form, which certifies that they have not made any reportable contributions to a candidate in the Borough of Franklin in the previous year and that the contract will prohibit them from making any reportable contributions through the term of the contract, and

WHEREAS, the Purchasing Agent has recommended the contract be awarded for \$31,100.00 and

WHEREAS, the Chief Financial Officer certifies the availability of funds and that the funds shall not exceed \$31,100.00

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of Franklin, County of Sussex, State of New Jersey, as follows:

1. The contract for crushing and milling concrete and blacktop is awarded for \$31,100.00 to B.G. Coston and Sons, LLC 3190 Route 94, Franklin, NJ.
2. The cost for the aforementioned services shall not exceed \$31,100.00
